## INSTRUCTIONS FOR A GIFT OF PUBLICLY TRADED SECURITIES

The following instructions are provided for both electronic transfers and the transfer of securities certificate(s).

### **Electronic Transfer**

- Please contact the Foundation office prior to your planned transfer of securities to discuss the transfer and the purpose of your gift.
- Your broker can arrange for the electronic transfer of shares to the Foundation's account upon receipt of your written instructions. The following information will be required:

The Ownership disclaimer form must be filled out in the presence of a notary public and bear the signature of the notary public. The certificate must be signed in the area noted as “form of transfer” and must be signed exactly as the name appears on the front of the certificate and be guaranteed by your banker. Please note that the legal name of the Foundation is **Colchester East Hants Health Centre Foundation**.
- When mailing the documents to the Foundation office the certificates and other forms should be mailed separately. Please use registered mail for the certificates.
- The amount of the donation receipt is based on the closing trading price of the securities on the day the Foundation Office receives delivery of the securities.
